# This week: The FCC; Do you know Part 97?

Part of my day job requires me to be very familiar with the Code of Federal Regulations or *CFRs.* Federal regulation of the airwaves has a long history predating WWI. Many times various government elements fought desperately to end amateur radio operation. The Federal Communications Commission (FCC) was created by the Communications Act of 1934 and combined the functions of the Federal Radio Commission and the wire (telephone and telegraph) regulation responsibilities of the Interstate Commerce Commission (ICC).

Why do the rules matter? When you applied for, received and then signed your amateur radio license, you acknowledged knowing and being familiar with *all* of the Part 97 rules! Part 97 derives its name from the portion of the CFRs that regulates communication.

The Federal Regulations are published in the *Federal Register* and can be found on line at https://www.ecfr.gov. Once there, browse the various titles until you come to Title 47-Telecommunications.

Notice the decimals are treated as numbers: ie: 97.11 is after 97.9, not 97.1.

Subpart A provides the legal standing to regulate the Amateur Radio Service and covers station location and licensing.

Subpart B is about operating your station

Subpart C covers Special Operations, including 97.203 Beacon Stations, 97.205 Repeater Stations and 97.215 Telecommand of Model Craft.

Subpart D Technical Standards grants us bands, emission types, power standards, etc.

Subpart E Emergency Communications

Subpart F covers examinations and the Volunteer Exam Coordinators and the Volunteer Examiners who provide test sessions and perform the actual testing.

APPENDIX 1 TO PART 97-PLACES WHERE THE AMATEUR SERVICE IS REGULATED BY THE FCC

In ITU Region 2, the amateur service is regulated by the FCC within the territorial limits of the 50 United States, District of Columbia, Caribbean Insular areas [Commonwealth of Puerto Rico, United States Virgin Islands (50 islets and cays) and Navassa Island], and Johnston Island (Islets East, Johnston, North and Sand) and Midway Island (Islets Eastern and Sand) in the Pacific Insular areas.

In ITU Region 3, the amateur service is regulated by the FCC within the Pacific Insular territorial limits of American Samoa (seven islands), Baker Island, Commonwealth of Northern Mariana Islands, Guam Island, Howland Island, Jarvis Island, Kingman Reef, Palmyra Island (more than 50 islets) and Wake Island (Islets Peale, Wake and Wilkes).

Part 97 is actually very short. The parts of Title 49 I work with in my day job typically require a several hundred page book for just parts 300-399 and a book about twice as thick for 200-299 and twice as thick again for 100-177 and 178-199. In some versions, 100-177 and 178-199 each require their own book.
