This week: Renew Amateur Radio License

Long time readers of this space will see there are many articles on radios, antennas, and other tips and tricks for operating. See <u>https://www.radioclub-carc.com/resources/</u> for more articles.

Congratulations!

Your Amateur Radio License was issued just about 10 years ago and you are now in the 90 day take-action window prior to expiration. This means your license is eligible for renewal. But since performing your last license transaction, the FCC systems have changed. What do you do?

It is sort of a two-part process. Depending on the nature of your FCC transaction you will need to work with two of the FCC systems:

- CORES Commission Registration System
- ULS Universal Licensing System

You may say you already registered with the FCC. Ok, but bear in mind the legacy FCC systems were retired in 2022 and replaced with newer systems.

I believe we can obtain the best results by dividing this license renewal process into two parts.

- Part A begins on Page 3 -- for those who updated their FCC CORES and FCC ULS credentials back in 2022, or anytime since then. An added requirement dimension of Part A is that those individuals must know their CORES User Name and their CORES Password.
- Part B begins on Page 10 -- for those who did not update their FCC CORES and FCC ULS and now need to play catch-up before dealing with their license renewal.

The instructions given for Part A and for Part B will be completely free-standing.

- If you know you updated CORES and ULS you only need to deal with Part A.
- If you know you did not update CORES and ULS you only need to deal with Part B.

If you are unsure of your status let's use the beginning of Part A to perform a couple of verification steps to determine whether you are registered in the new FCC systems.

GENERAL NOTES:

Heed the following warning while working with the FCC CORES or FCC LICENSING MANAGER (ULS)

WARNING

DO NOT use your browsers back button to return to a previous page.

- Always use the "Go Back" link.
- If you don't use the "Go Back" link, you will have to log back into CORES.

Refer to the image at the bottom of the previous page to see an example of the "Go Back" link.

After entering your CORES User ID and Password the FCC will e-Mail a six-character code to the e-Mail address-of-record in your account. This code is valid for one-time use only. Time limits are involved as well.

Without losing your place on the CORES screen, open your e-Mail service. You may wish to keep CORES open in its screen and open a new screen for your e-Mail. Find the e-Mail sent to you by the FCC, make note of the authentication code, return to the CORES screen, enter the code. If all is well your screen will be updated.

PART A INSTRUCTIONS If You Updated CORES and ULS since 2022.

VERIFY FCC CORES REGISTRATION

You will need the User Name and Password to access your CORES account. If you do not remember your CORES credentials you should use Part B.

Visit the FCC CORES web site at: https://apps.fcc.gov/cores/userLogin.do

Go to the USERNAME LOGIN area of the screen. Enter your User Name Enter your Password Press the LOG IN button Wait for a response from the system

Effective as of March 29, 2024 the FCC CORES will implement Two-Factor Authentication. At this point the FCC will e-Mail a six-character code to the e-Mail address-of-record in your account. This code is valid for one-time use only. Time limits are involved as well.

Without losing your place on the CORES screen, open your e-Mail service. You may wish to keep CORES open in its screen and open a new screen for your e-Mail. Find the e-Mail sent to you by the FCC, make note of the authentication code, return to the CORES screen, enter the code. If all is well your screen will be updated.

If you are shown the page titled USER HOME that means you are registered with CORES. Continue at the next step.

You can remain logged in to the FCC CORES system if desired. Or, you can log off and come back to FCC CORES later.

VERIFY YOUR FCC FRN

You will need your FRN number. It is printed on the front of your Amateur Radio license. If you do not remember your password you can obtain it using any of the FCC Database Search tools that are accessible on the Internet.

For example: Visit website KB9AT.com Select DOCUMENTATION in the top menu bar. Select LICENSE SEARCH in the graphical section below the top menu.

When you are shown the FCC AMATEUR LICENSE SEARCH screen, go down to LICENSE DETAIL.

Type your call sign in the CALL SIGN field. Go to the bottom row, right side. Click the SEARCH button. Wait for a response from the FCC system.

When you are shown SEARCH RESULTS, find your call sign. Read to the right where your FRN is shown.

Resume your use of the FCC CORES system at the User Home page. Or, if necessary, Re-visit the FCC CORES web site at: <u>https://apps.fcc.gov/cores/userLogin.do</u> Provide your User Name and Password credentials. Press the LOG IN button.

From the FCC CORES User Home screen, Read the selections. Click the link that begins with the words: MANAGE EXISTING FRNs.

The next screen will be displayed. Select the link labeled MANAGE FRNs.

If your CORES Account has been linked to your FRN you will see your FRN and your NAME.

For grins and giggles, remember this screen. At a later step you will return to this screen and use the FRN FINANCIAL button and link to VIEW/MAKE PAYMENT of your FCC fee(s).

If these verification steps show that you are registered in the new FCC systems you may continue with the next steps in Part A to initiate your license renewal.

Otherwise, you need to change to Part B where you will register for a **NEW CORES ACCOUNT**.

INITIATE RENEWAL OF YOUR LICENSE

Visit the FCC License Manager web site at: https://wireless2.fcc.gov/UIsEntry/licManager/login.jsp

You will be shown the FCC LICENSE MANAGER screen with Log In options. Provide your FRN Number and your Password where requested. Press ENTER Wait for the License Manager system to respond.

You should expect to see a screen containing the words: My Licenses License [your call sign] at a glance.

You should see your Name, Address, Telephone, and eMail information. Verify its accuracy. Use the UPDATE option if necessary to make changes.

Editor's Note: At this point the ARRL License Renewal video shows a message telling that your license is up for renewal. The presenter says you can click on that message and avoid the next three blocks of instructions.

On the left side of your screen, locate the heading labeled My Licenses. Click on Renew Licenses located below the My Licenses heading.

You will be shown two boxes where you will take the next actions. The box on the left is labeled *My Licenses*. It contains your licenses. Select by clicking the one license that you want to renew. Click the ADD button located between the two boxes

Observe that your license has moved out of the *My Licenses* box on the left and into the *Licenses to Renew* box on the right. Click the SELECT ALL button located below the *Licenses to Renew* box.

Resume here if you were able to avoid the previous three blocks by clicking the license renewal reminder message mentioned in the Editor's Note.

Click the CONTINUE button located in the lower right corner of your screen.

There are a series of questions for you to answer and statements for you to acknowledge. Because your Editor is not actually renewing a license, I am unable to navigate through those questions. My understanding is the questions and statements are self-explanatory. I trust that you will know what needs to be done.

Your goal is the reach a point where the FCC License Manager offers you some type of summary document related to the license renewal. You may wish to print that summary document for your records.

PAY YOUR FCC APPLICATION FEE

Step 1 – Visit the FCC CORES web site: <u>https://apps.fcc.gov/cores/userLogin.do</u> It is possible that the FCC License Manager will redirect you to the FCC CORES page for payment processing after you complete the license renewal steps. If not, navigate the links shown here.

Step 7a – On the screen shown above, select the payer's FRN using the pulldown box. Typically, only one FRN will be listed.

Select this FRN even if the payment is being made by someone else. (e.g., Parents, grandparents, aunts/uncles, spouse)

Step 7b – On the screen shown above, choose the desired payment method and provide the requested payment information.

• Paying online using a credit card or debit card is the easiest and fastest.

• Paying online using an Electronic Debit (ACH) from a checking or savings account is also fast.

• Wire transfers usually require a bank fee for this service.

Go to the area titled NEED A USERNAME?

If you are unsure of whether you previously registered a New CORES Account you should consider using the CHECK USERNAME AVAILABILITY option prior to continuing. If your eMail address has been used it might have been something you entered. In that case you might want to reset your password rather than create a new account.

Click the REGISTER button.

You will be taken to the page titled: Create New Account.

You need to provide a valid eMail address which becomes your FCC CORES User Name. You need to choose and provide an acceptable Password. The minimum requirements are stated on the Create New Account screen.

You will be requested to provide your full name, a secondary eMail address, a telephone number, a security question and its answer.

Make a written note of the credentials you provided.

You will need the User Name and Password information every time you transact business with the FCC.

Press the CREATE ACCOUNT button when all requested information has been provided.

You will almost immediately receive an eMail from the FCC requesting you to verify the eMail address you provided. An example of the verification eMail is shown below.

Make sure your FRN is entered correctly. If you don't enter your FRN correctly, the incorrect FRN will be associated with your username. You will have to contact the CORES help desk to correct your mistake: (877) 480-3201, Option 1 (Mon - Fri, 8am - 6pm ET).

Your Editor is not actually creating a CORES Account at this time. Therefore, he is unable to go through the screens which would have been displayed after clicking the CONTINUE button.

My understanding is there are questions and may be statements for you to acknowledge. I believe those questions and statements are self-explanatory. I trust that you will know what needs to be done.

Once you have seen the message on screen confirming that your FRN and your CORES Account are successfully linked, you are at a point where the FCC is ready to receive your license renewal request.
